I/We the undersigned herewith apply to participate in the **Nanaimo Professional Craft Fair, November 5, 6 & 7 2010, at Beban Park Social Centre, 2300 Bowen Rd., Nanaimo, BC**, subject to acceptance by the Jury of the Nanaimo Professional Craft Fair. On acceptance you will be notified what booth number has been assigned to you. A full refund will accompany any rejected application. **The jury will take place as required after the main jury that is done at the end of March each year.**

**1. PAYMENT FOR SPACE**-only registered Applicants paid in full may participate in the Nanaimo Professional Craft Fair. Payment of **\$50.00** must be included with this completed application to reserve a jury spot, the **balance to be paid by two postdated cheques dated June 1, 2010 & October 1, 2010 (included with application).** Applications received after October 1, 2010 must include full payment. In the event an application is not accepted by Nanaimo Professional Craft Fair for any reason, a full refund will be made (**\$15.00 fee will be charged for all N.S.F cheques**)

**Withdrawal or cancellation** by Applicant prior to October 1, 2010 will be subject to a \$50.00 service charge; the remainder to be refunded. **After October 1, 2010, withdrawal will result in forfeiture of the entire amount paid** to Nanaimo Professional Craft Fair.

**2. CHARACTER OF EXHIBIT**-Nanaimo Professional Craft Fair reserves the right to decline or prohibit or restrict any exhibit, activity or conduct within the exhibit area which in its opinion is not suitable, such as raffles, sales of imported or manufactured goods or any other **non-craft pursuit.**

**3. RENTAL CHARGES**-Rental charges for booths are as follows: Single 8x10 booth, **\$325.00**; corner booth **\$375.00**; 8x14 booth **\$475.00** for three days, payable as per clause #1 above. All tax and license costs pertaining to booth rental, including temporary City of Nanaimo Business License and GST will be paid by Nanaimo Professional Craft Fair. The contracted space is for the sole and exclusive use of the Registered Exhibitor and **may not** be sub-leased. When two businesses are sharing a booth, each **must fill out & sign** an application form.

**4. BOOTHS**-Booths shall include 8 foot backdrop, most 8x10 enclosure, **ONE** 8'x30" table, chair(s), 2 lights and a power outlet. Corner booths may be open on 2 sides, if desired by removal of the end partition. An additional **table may be available if reserved in advance.** **The charge for this additional table is \$20.00.**

**5. INSTALLATION AND DISMANTLING**-Exhibits shall be installed by the registered exhibitors between the hours of 8:00 a.m. and must be fully installed by 12:00 (noon) on Friday, November 5, 2010. No exhibit thus installed may be removed or dismantled prior to 4:00 p.m. November 7, 2010. Exhibits must be removed from the premises no later than 7:00 p.m. November 7, 2010.

**6. EXHIBITION HOURS**-Exhibitors shall staff their booths 12:00pm till 8:00pm November 5, 10:00am till 5:00pm November 6, 10:00 am till 4:00 pm November 7, 2010.

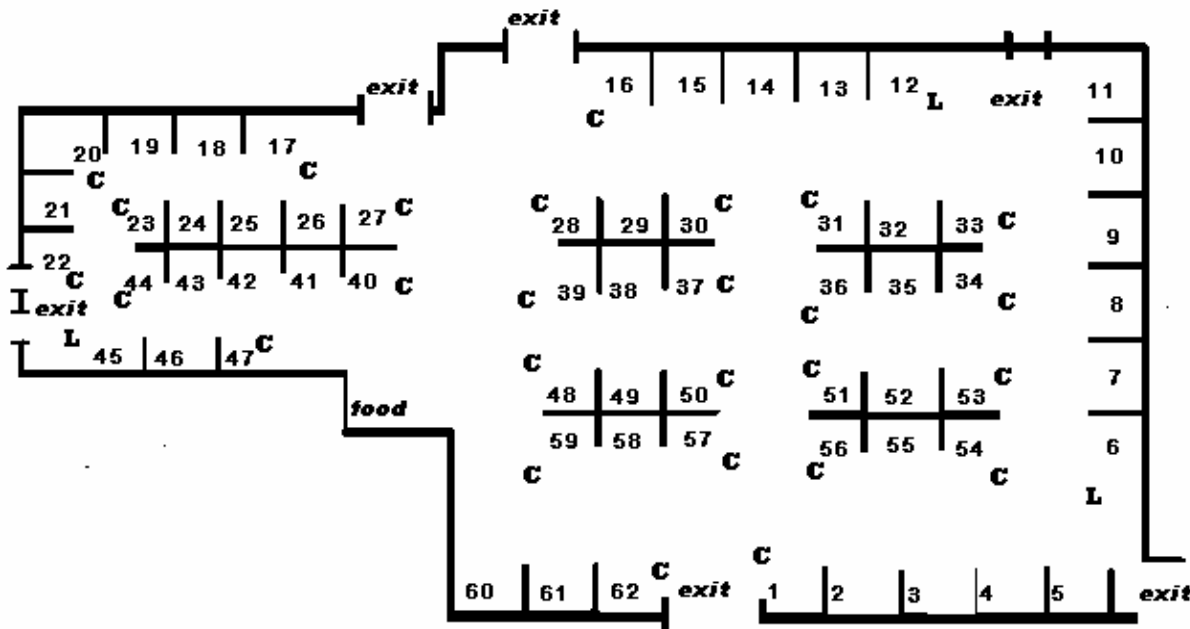
**7. INSTRUCTIONS**-The Exhibitor must closely observe the instructions issued by Nanaimo Professional Craft Fair whose decisions are binding.

**8. DAMAGE TO FACILITIES-**The Registered Exhibitor(s) will reimburse the Regional District of Nanaimo for any damage done to its property by the Registered Exhibitor(s) or by any employees or agents there of.

**9. INDENMIFICATION-**The Registered Exhibitor agrees to indemnify and save harmless Nanaimo Professional Craft Fair, Woodgrove Christian Community Church and the Regional District of Nanaimo from any and all liability arising out of the Exhibitor's participation in the Twenty First Annual Nanaimo Professional Craft Fair, including liability arising out of the Exhibitor's exhibit itself and the actions of the Exhibitors' employees and/or agents. It is recommended that the Exhibitor carry **suitable insurance** and all expenses of insurance shall be borne by the Exhibitor. In addition the afore mentioned parties shall not be liable in damages otherwise for failure to carry out the terms of the Agreement in whole or in part where caused directly or indirectly, by or in consequence of fire, storm, flood, war, rebellion, insurrection, riot, civil commotion, strike or by any cause whatever beyond the control of Management whether similar to or dissimilar from the causes enumerated herein. In any event, liability to the Registered Exhibitor for failure to carry out the terms of this agreement shall be limited to the return of the rental fee in whole or in part at the discretion of the Nanaimo Professional Craft Fair.

**10. SECURITY & LIABILITY-**Nanaimo Professional Craft Fair shall be responsible for the general security of the craft fair premises from 8:00 am November 5, 2010 until 8:00 pm November 7, 2010 but shall not be responsible for individual exhibits when the Exhibitor's booth is staffed and open to the public or not, and shall not in any event be responsible for care and control of the Exhibitor's equipment and property or the equipment and property of third parties used by the Exhibitor, all of which shall be the sole responsibility of the Exhibitor throughout the Nanaimo Professional Craft Fair.
