I/We the undersigned herewith apply to participate in the Nanaimo Professional Craft Fair, **November 2nd, 3rd & 4th, 2018** at Beban Park Social Centre, 2300 Bowen Rd., Nanaimo, BC, subject to acceptance by the jury of the Nanaimo Professional Craft Fair. On acceptance you will be notified what booth number has been assigned to you. A full refund will accompany any rejected application. The main jury will take place the end of February 2018, and from there will take place as required until the booths are full. Please note that all food vendors must submit with their application their food safe certification and your product must be processed in your certified inspected kitchen.

1. PAYMENT FOR SPACE: Only registered Applicants paid in full may participate in the Nanaimo Professional Craft Fair. Payment of \$50.00 must be included with this completed application to reserve a jury spot, the BALANCE to be paid by two post - dated cheques dated June 1, 2018 & October 1, 2018 must be included with the application. Applications received after October 1st must include full payment. In the event an application is not accepted by Nanaimo Professional Craft Fair for any reason, a full refund will be made. There is a \$40.00 charge for N.S.F. cheques. Please attach, or mail, photos of your craft products and a photo of you working at your craft to assist in the jury process.

WITHDRAWAL OR CANCELLATION by application prior to October 1, 2018 will be subject to a \$100.00 service charge; the remainder will be refunded. After OCTOBER 1st, 2018, withdrawal will result in forfeiture of the entire amount paid.

2. CHARACTER OF EXHIBIT: Nanaimo Professional Craft Fair reserves the right to decline or prohibit or restrict, any exhibit, activity, or conduct within the exhibit area which in its opinion is not suitable, for examples – raffles, sales of imported or manufactured goods or any other non-craft pursuit.

3. RENTAL CHARGES: Rental charges for booths are as follows and are subject to GST:

Single: 8x10wide booth: \$355.00; Corner: 8x10wide booth: \$425.00; Large: 8x14wide booth: \$495.00 for the complete 3 days, payable as per clause #1 above. Socan and licence costs pertaining to booth rental, including temporary City of Nanaimo Business Licence, will be paid by Nanaimo Professional Craft Fair. The contracted space is for the sole and exclusive use of the Registered Craft Vendor and may not be subleased. If two businesses are sharing a booth, each must fill out & sign an application form. The business is juried separately but the cost of the booth may be split with whatever agreement the joint share has worked out. Should one or the other not be accepted we will notify both parties.

4. BOOTHS: Booths shall include 8' high backdrop, most with 8'x10' ft. enclosure, 30" dividing drape, ONE 8'x30" table skirted in navy blue, chair(s), 2 lights and a power outlet. Corner booths are open on two sides. Additional tables and linens may be ordered on page 5 of this Contract and Application Form. These items will be placed in your booth ready for you to set up.

5. INSTALLATION AND DISMANTLING: Exhibits shall be installed by the registered craft vender between the hours of 8:00 am and must be fully installed by 12:00 pm (Noon) on Friday, November 2nd, 2018. No exhibit thus installed may be removed or dismantled prior to 4:00 pm, November 4th, 2018. Exhibits must be removed from the premises no later than 7:00 pm November 4th, 2018.

6. EXHIBITION HOURS: Craft Venders shall staff their booths from 12:00pm noon, until 6:30pm November 2nd, from 10:00am until 5:00pm November 3rd; and from 10:00am until 4:00pm November 4th, 2018. **Early tear down of booths on the final day will not be tolerated.**

7. INSTRUCTIONS: The Craft Vender must closely observe the instructions issued by Nanaimo Professional Craft Fair whose decisions are binding.

8. DAMAGE TO FACILITIES: The Registered Craft Vender will reimburse the Regional District of Nanaimo for any damage done to its property by the Registered Craft Vender or by any employees or agents thereof.

9. INDENMIFICATIONS: The Registered Craft Vender agrees to indemnify and save harmless Nanaimo Professional Craft Fair, Jayne Willie and the Regional District of Nanaimo from any and all liability arising out of the Craft Vender's participation in the Twenty-Eighth Annual Nanaimo Professional Craft Fair, including liability arising out of the Craft Vender's exhibit itself and the actions of the Craft Vender's employees and/or agents. It is recommended that the **Craft Vender carry suitable insurance** and all expenses of insurance shall be borne by the Craft Vender. In addition the afore mentioned parties shall not be liable in damages otherwise for failure to carry out the terms of the Agreement in whole or in part where caused directly or indirectly, by or in consequence of fire, storm, flood, war, rebellion, insurrection, riot, civil commotion, strike or by any cause whatever beyond the control of Management whether similar to or dissimilar from the causes enumerated herein. In any event, liability to the Registered Craft Vender for failure to carry out the terms of this agreement shall be limited to the return of the rental fee in whole or part at the discretion of the Nanaimo Professional Craft Fair.

10. SECURITY & LIABILITY: Nanaimo Professional Craft Fair shall be responsible for the general security of the craft fair premises from 8:00am November 2nd, 2018 until 7:00pm November 4th, 2018 but shall NOT be responsible for individual exhibits when the Craft Vender`s booth is staffed and open to the public or not, and shall not in any event be responsible for care and control of the Craft Vender`s equipment and property or the equipment and property of third parties used by the Craft Vender, all of which shall be the sole responsibility of the Craft Vender throughout the Nanaimo Professional Craft Fair.
